
Below is the town map of my property along with the section of class VI road I'd like to improve.

I have engaged McGillis Enterprises for their opinion of scope of work needed to bring this road to a better drivable Class VI road and was advised that about 30 yards of fill would be needed to be brought in along with clearing some brush and removing some stumps. There are no trees to cut down. They would bring in the dirt and remove the stumps and brush and use their equipment to level the dirt out from the end of the tarred road to my property.

For the initial entrance of Seventh Range Road a culvert is needed to let the water pass from the left side of the road to the right for proper drainage. A 18" culvert is recommended for that. To make the transition from the road more gradual you will need about 45 ton of fill or approximately 30 yards. This equates to about 3 dump truck loads. As far as the road I believe there is little material to be added. There appears to be no trees that will impede access to the lot however there are numerous stumps and sections of underbrush. To make a properly accessible road these stumps will need to be excavated and brush cleared. This work will make the lot of Mr. Bennett accessible by car at minimum.






