III. Scheduled Meetings:

a. Public Hearing acceptance of Highway Block Grant Aid in accordance with RSA 31:95-b III (a) Open Public Hearing at 6:31pm

Selectman Crockwell moved to accept in accordance with RSA 31:95-bIII (a) the following \$141,062.92 from the State of NH Highway Grant for funding received from Senate Bill 38 which is to be used for highway construction, reconstruction or maintenance. Motion seconded by Selectman Goulet. Motion passed 4-0.

Selectman Crockwell moved to approve Chapter 133 Solid Waste Management as presented. Motion seconded by Selectman Greco. Motion passed 4-0

 Public Hearing Town Code Chapter 180 Snow Control Policy Section 180-6 Manpower; Section 180-9 Parking. Open Public Hearing at 6:39pm

A Winter Parking Ban is being implemented effective 1/1-3/31 each year.

John Saucier of Remington Ct requested to know the reason for the new implementation. Selectman Courtemanche states the reasoning is due to having trouble moving the parked vehicles during the snow storms.

Rose Galligan of North Browning Court expressed her concern with the parking in the circle at Littlefield Condos. Selectman Courtemanche reassured Ms. Galligan that the circle was included in the parking ban. Ms. Galligan had additional concerns about the Circle that the Selectman agreed to discuss at a future meeting as it did not pertain to the Public Hearing.

Dana Carlucci requested to know if there would still be an exception for the Downtown Area and also wondering if the DPW will be doing night snow removal this year. Per Jim Boisvert they are hoping to complete the snow removal at night again however this will be played by ear. In addition the parking in the downtown area will remain open during snow storms unless stated otherwise.

Sandy Valine of South Browning Court requested to know the hours of the parking ban. David Jodoin stated the hours of the ban is from 12pm-6am

Public Hearing closed at 6:54pm

Action" Selectman Goulet moved to approve Chapter 180 Snow and Ice Control Policy as amended. Motion seconded by Selectman Crockwell. Motion passed 4-0

e. Public Hearing Town Code Chapter 186-18 Depositing leaves or placing debris on Town streets, sidewalks, or rights of way. Open Public Hearing 6:55pm

Dana Carlucci stated that the Old Home Day Committee has been approached in the past about having a beer tent at the event. Would this policy make this not possible? Per Selectman Courtemanche yes this would make a beer tent at the event against town code.

Action: Selectman Goulet moved approve Chapter 187 Town Building and Grounds as presented. Motion seconded by Selectman Greco. Motion passed 4-0

 g. Public Hearing Town Code Chapter 191 Schedule VII Vehicles and Traffic Section 191-1 definitions: Section 191-9 A prohibited stopping, standing or parking; Schedule 191-19 Schedule V: Time limit parking. Open Public Hearing at 7:02pm

Jim Boisvert wanted to confirm that at 4 Union St there would be no parking during the day unless an occupant of the building tenant/patron. This was confirmed that this is what is proposed.

Dana Carlucci expressed his concern that there are frequently many spaced that are not used. He is concerned with the downtown community losing these parking spaces. In addition Mr. Carlucci stated he reached out to the owner of Mei's and Famous Pizza where the 15min parking currently is to get their reaction. The owners of Mei's likes the 15 minute spots for takeout orders, the new owners of Famous pizza did not return his call.

David Jodoin states a concern with the Union Street parking as there are a lot of outside organizations that use the conference room there for meetings. It will be requested that these be called into Linda at the Town Hall so that she can let the Police Department know extra cars may be there. In addition signs will be posted in two spots to ensure all people will be able to see.

Public Hearing closed at 7:22pm
