2. Merrimack River Watershed: Caroly Shumway and Tim Fleury

Have an ongoing project with US Forest Service, NRWA, UNH Cooperative Extension, and others. Was very polluted 40 years ago, but factory dumping and others have been cleaned up so it is much better. Now in threatened because so much private forest land in the watershed *could* be developed rapidly and change the way water drains downstream. Purpose of presentation to show us what information they have in terms of ordinance management with municipalities to help with planning, drinking water protection and wildlife protection. Overall goals to get eroded shorelines planted and shorelines permanently protected.
