 - a. Irving Parcel: 301-323 Fourth Range Road Site Walk postponed due to rain, Scheduled next for Tuesday July 13 @5:30pm RAIN OR SHINE!
 - **b.** Other Lot abutting Taylor/Keniston has sold to a single homeowner. Discussion of implications.
- 3. Planning Board Applications
 - a. **798 Silver Hills Drive** Would like to expand operations for manufacturing and parking spaces. Concerns: Increased impervious surface area,
 - b. 801 Plausawa Hill Road 62 ac lot, want to subdivide into 3 residential lots. 2 are under 3 ac with one large lot with existing house & barn. Back of one of the smaller lots has wetlands. Discussion of wetland medallion placement. Overall positive.
 - c. 409-415 Buck Street One lot being split into two lots for a single family home. Across street from Dudley Hill Road. Wetland issues, part of floodplain of Suncook River. Special Use Permit Application because part of Aquifer District. Area identified as valuable wildlife habitat which does not expect to be disturbed. Due to the lack of information it is hard to make a meaningful comment. Location and wetlands are a concern.
