B. CIP 2021

Rose presented a new plan to lower CIP tennis repairs for 2021. Vermont Tennis Courts said if all cracks would be filled this year then in 2021 crack repair and resurfacing would cost less. Rose mentioned that we could use revolving money and improvement budget line to get this done \$2,983 plus \$200 for each set of pickle ball lines (2). She then would submit 3 options for 2021 resurfacing to CIP.
