 - a. They reviewed the list provided in the packet for the \$25,000.00 budget for this year. They were pleased that crack sealing was holding up and instead of 2-3 years to crack seal it could be stretched out to 3-4 years. VJ will meet with CNHRP to go over future crack sealing plans.
 - b. Between the three items under Roads Bids Summary, there is about a million dollars of work but the budget is \$750,000.00 so they will have to make some adjustments. VJ will prepare a revised 2023 Road list for the committee.

The committee discussed issues they had had with GMI in the past and recommended that their bids be eliminated due to the fact that getting them to come back to fix issues they had left were not met with cooperation and once those issues were finally taken care they charged the additional costs to the Town.
