98 Sheep Davis Rd. plans show a 4inch sewer line where a 6 inch is required due to the property being commercial. The sewer department will also need additional information on the number of employees now vs. after the merger for this property.

245 Pembroke Hill Rd. currently it is unknown if the home will be connected to the Town's sewer system. This request is only having to do with the driveway crossing a wetlands. Paulette asked the developer to protect the existing force mains in the easement where the driveway is going to be located even while this easement is for private individuals and not a Town easement.
