#### CHAPTER 150

# BICYCLES, SKATEBOARDS, SCOOTERS AND ROLLER SKATES

#### § 150-1 Prohibited areas.

A. No person shall ride a skateboard, scooter, or use roller skates/roller blades upon the following streets or sidewalks of the following areas:

Name of Street	Side	Location
Main Street	Both	From Church Street to Pembroke/Allenstown town line
Glass Street	Both	Church Street to Main Street
Central Street	Both	Main Street to Church Street
Union Street	Both	Main Street to Prospect Street

B. No person shall ride a skateboard, scooter, or use roller skates/roller blades anywhere on any of the following municipal properties, including but not limited to public parks; public cemeteries; Municipal Parking Lot, Central Street; Town Hall, 311 Pembroke Street; Police Station, 4 Union Street; Fire Station, 247 Pembroke Street; Library, 261 Pembroke Street.

#### § 150-2 Reckless operation prohibited.

No person shall ride or operate a bicycle, scooter, skateboard, roller skates/roller blades in a reckless or uncontrollable manner on any street, roadway, or sidewalk located within the corporate limits of the Town of Pembroke.

### § 150-3 Unattended bicycles, scooters and skateboards.

No bicycle, scooter or skateboard shall be left unattended on any sidewalk in the town in any way that impedes or endangers pedestrians.

### § 150-4 Construction, placement and use of ramps prohibited.

No person shall construct, place or use ramp or ramp-like structures on any public street or on any of the following municipal properties, including but not limited to public parks; public cemeteries; Municipal Parking Lot, Central Street; Town Hall, 311 Pembroke Street; Police Station, 4 Union Street; Fire Station, 247 Pembroke Street; and the Library, 261 Pembroke Street.

## § 150-5 Violations and penalties.

- A. Any person violating the provisions of this chapter shall be subject to a fine of five dollars (\$5.) for a first offense and ten dollars (\$10.) for each subsequent offense.
- B. In the event that any law enforcement officer of the Town of Pembroke observes any minor child operating a bicycle, scooter, skateboard, or roller skates in violation of this chapter, the law enforcement officer may confiscate the bicycle, scooter, skateboard, or roller skates operated by said minor child and shall return the bicycle, scooter, skateboard, or roller skates only to the said minor's parent or guardian. The law enforcement officer shall be authorized to confiscate a bicycle, scooter, skateboard, or roller skates under the provisions of this subsection whether or not he or she issues a citation for violations of this chapter.
