  - Study for Source Water Capacity Still waiting on the final report.
  - Asset Management 1<sup>st</sup> workshop meeting in April with Matt, DES & Underwood.
  - Strategic Planning Grant GZA will start groundwater exploration in the next couple of weeks.

Lead Service Lines – Nothing new at this time.

Station Analyzers – All are installed and operational and meet all DES requirements.

New Dump Truck- Nothing new at this time.

Leak Detector Equipment – We will be getting new leak detector equipment that also has included a lead correlator, which will help in detecting lead lines. This will be funded through the ARPA Funds.

Suncook Pond Water Meter Replacement – Matt is working with Suncook Pond to try to get a meter installed in each of the 10 buildings instead of replacing the 8" meter in the pit.

576 Pembroke St additional unit – The owner of the property wants the Board to waive the connection for the additional unit that he wants to put in. The Board has denied this request.
