III. Scheduled Meetings:

A. Chief Gilman (Police Department), Chief Paulson (Fire Department), Jim Boisvert (DPW Director)

All three individuals were present to discuss parking issues during the last snow storm. Jim Boisvert explained that during the last storm there were issues with cars being parked in the circle at Littlefield Condominiums making it impossible to plow. The Police Department did come down and find the owners however the cars were parked in the circle again about an hour later.

It was explained by Chief Gilman that the Police Officer needs to make an effort to find the owner of the vehicle before towing. However the Police Chief was unaware there were issues to this extent until today. Chief Paulson stated that his apparatus does not have an issue getting through circle at Littlefield Condos, however he finds some of the downtown street more challenging. However at this point he does not feel anything should be done to restrict parking. It could become a problem though as we get more snow and the roadway shrinks.

Discussion was had to what possible options are to resolve this problem. Some suggestions include bringing back the winter parking ban, instituting a violation monetary fee to those not abiding by the snow emergency or towing the vehicle. Before any discussions are made Chief Gilman has requested a little more time to work with his officers to try to avoid these measures having to be taken. The Board agreed to allow the Police Chief more time to try and resolve some of the issues.
