# BOARD OF SELECTMEN TOWN OF PEMBROKE, NH April 16, 2018 at 6:30 PM

#### I. Call to Order:

Chairman Tina Courtemanche called the meeting to order at 6:30pm.

#### **II. Citizen Comment:**

Kevin Gagne was present to request the Selectman's approval in applying for a grant that would fund replacing some culverts along the trails. In addition he is requesting the trail permit for the year. In the past this was done in the spring and would like to get it back on track for this timeframe.

Action: Selectman Greco moved to approve the application for grant aid and to also approve Snowmobile Trail Permission for the upcoming year. Motion seconded by Selectman Crockwell. Motion passed 5-0.

### **III. Scheduled Meetings:**

#### A. 4 Union St

Jim Boisvert was present to request the amount of \$10430.00 to resurface and repair the upper parking lot and the road down to the sewer department. This does not include the area in front of the sewer department due to concerns that the roller may cause damage through vibration to the retaining wall. Damage was done in years past were snow was piled there. Tom Hebert has spoken to those that would be doing the masonry/concreate work and they are willing to patch however he is unsure it will last. The building Committee will re-visit the wall issue.

The money for this project will come out of the Roads and Paving Line. However the concrete work that would need to be done will come out the operating budget. Jim Boisvert to speak with Advanced Excavating to get pricing to pave right up to the doorway.

Action: Selectman Greco moved to accept the amount of 10,430.00 from Advanced Excavating to resurface 4 Union St and waive the bidding process. Motion seconded by Selectman Sheldon. Motion passed 5-0.

#### B. Disposal of Old Cruiser:

Action: Selectman Sheldon moved to salvage the cruiser and deposit the money received from this into the general operating fund. Motion seconded by Selectman Greco. Motion passed 5-0.

## A. Ratify the Vote on cruiser purchase

Action: Selectman Sheldon made a motion to ratify the vote on the cruiser purchase from MacMulkin Chevrolet in the amount of \$34,565 and to waive the bid requirements since this is the State bid and authorize the Chief to move forward with the purchase. Motion seconded by Selectman Bond. Motion passed 5-0.

## B. Approve Rebids on 4 Union St repairs

Action: Selectman Sheldon moved to approve the contract with New Heights Roofing for repair work at 4 Union Street with a sum not to exceed \$19,400. Money will come from the Town Building Capital Reserve Fund. Motion seconded by Selectman Greco. Motion passed 5-0.

Updated list given to Selectman. The Board will need to decide on May 7<sup>th</sup> which property they will take by deed.
