- 1. Call to Order @7:04 pm
- 2. Conservation Lands
- **a. Butterfield: Logging Report** Completed (Final Account attached) Cut up to 7" diameter for Canadian market. Ron Klemarczyk (forester) recommended we use money from the timber sale to clear invasive species on edge including bittersweet and autumn olive.
  - **b. Hillman: Lease Renewal** Ammy talked to Lee Grimes and he has been working with Jay Pritchard has every intention of continuing to farm. Intend to plant corn May 10-15 and harvest end of September. Chris LaValley of Allenstown was interested in taking over if things fell through with Grimes.
  - **c. Beacon Hill** Ammy called the Municipal Association, Spoke with Atty. Buckley about selling front house lot. It can be done but has to go through town meeting and lots of paperwork and potential cost involved. We may need to rethink this. We need to have a sign done for this lot. Carol Moved to buy a sign from the State Prison Industries up to \$150.00. Steve seconded. All in favor.

ACTION ITEM: Ayn will call sign shop and order sign for Beacon Hill and bring minutes to Finance for payment.

**d. Ames Brook** Need to call Jim Boisvert to get rocks placed. May be some other rocks available on Rte. 3 to use for Butterfield.

ACTION ITEM: Steve will place stakes where the rocks should go on Ames, Carol will do Butterfield and both will call me when done so Ayn will contact Jim Boisvert to place the rocks.

- **e. Annual Monitoring Day on April 11** Baseline Documentation for Beacon Hill done by Ammy and Brian, Butterfield and Bragfield also done along with Schuett.
- **f. Other** Ayn suggests we take note in our monitoring report where we see invasive plants and have an "Eliminate the Aliens" Day in October.
- **3. Review and Approve Minutes ~ March 9th** Brian did them so they were, of course, excellent. All in favor to accept as written, Ayn abstains.

Planning Board Applications** Dental lab proposed on NH Rte 28, want to make sure stormwater runoff taken care of, hazardous waste not disposed of on property in any form (liquid, solid, dust or fumes), concern about industrial activity in Agricultural area and aquifer protection district, would not want more similar types of activity to take over.

He has been talking to CAI corp. who are in charge of the GIS maps for the town and because they are in the process of updating the town map they can do it at no cost as long as Rick can get the data to CAI corp. by Monday. David Jodoin approved.
