- 8- Part owner of Suncook PO. This survey would be best completed by staff at Suncook PO
- A business tax base should be concentrated on in order to reduce overall tax rate.
- A recycling program and recreational programs for children of all ages. I have six children ages 2 to 22 years of age and there is nothing to do for them.
- A stop light is needed at the corner of Pembroke Hill Road. All town officials & BOS should sit in the driving station parking lot and see what happens on this hill each morning between 7:30-8:00 am. Pembroke Hill road should have 3 lanes across with a left and right turn lane. Were it not for the school busses and other sympathetic drivers who STOP on Pembroke Rd. there would be no way the traffic on Pembroke Hill Rd. could get on to Rt.3. Ever since the other traffic lights were installed at the school, and down rt 3, the traffic flows in huge lines, rather than intermittent. It makes it almost impossible to get onto Rt3 at high commute times.
- Affordable housing (2)
- Always improve schools. There is a good community here, but I have noticed landowners pretty much have first priority here. I'm a renter. When my landlord's taxes go up, so does my rent. So guess what that means I pay taxes too. I live in this community just as much as a landowner and should have the same rights and be treated with the same respect. There should be equality.

- As a member of active duty Army currently stationed at FT Hood TX we have been extremely pleased
 with the level of cooperation and assistance we have received with managing the aspects of our lives that
 still link us to Pembroke. The small town feel of Pembroke is what makes the town attractive to live in
 and shouldn't be sacrificed in the name of growth.
- Assuming that I get an annual cost of living increase of 3% I am happy to pass that along with 3% tax increase
- Atv trail, access areas. Need proper trails for people to ride.
- Available parking space.
- B1 is unrealistic and needs to be adjusted. Some streets are not available for business use. Large multiunit housing places an unreasonable burden on the single family home owner.
- Balance the town budget in an equitable manner... one that does not drive away current residents in a
 financial conundrum. They are the people who initially made this town, but in terms of percentage,
 can ... in volume/capacity, no longer afford to live, nor continue to contribute to the essence of a tight
 nit community environment. My comments are not meant derogatorily, only directed as to the "powers
 to be", as a meaningful manner of truthfully answering this questionnaire...
- Be cautious of how much development is included in the "master plan". Pembroke is a small town, rich in history, dating back to pre-revolutionary times and was never meant to be mutated into some suburban/commercial nightmare. Whatever natural areas that still exist should be preserved and not obliterated by ugly sub-divisions and strip malls. You don't want to see our town transformed into a Hooksett, or worse, a Derry, but that seems to be the direction its headed. New Hampshire is rapidly losing it's beauty and charm to the bulldozer. Don't let Pembroke become another statistic.
- Before any additional taxes should be assessed. Town employee's salaries need to be cut. First, the
 town administrator should live in the town they over-see. Second, there is no need to have the town
 hall open 5 days a week get online. Finally, before you cut my trash pick-up (the only service I get)
 start holding the work crew accountable I am tired of seeing them sitting in my road for hours doing
 nothing and then complaining they don't get paid enough.
- Better Town management. Less waste. Better understanding of people interest in our community. Treat them with respect.
- Better use of tax dollars
- Bring industry to town to lower taxes & stop allowing single family homes to be built. It's causing
 overcrowded classrooms and causing new roads to be built & maintained.
- Building permits should be limited.
- Bus availability to new senior center in Concord and to the mall would be great walking trails great
 idea.
- Businesses in the Village District are almost all inaccessible to wheelchair users. Business owners almost all claim that Code Enforcer "will not allow them to alter access points at sidewalk", while Code Enforcement Officer says this is not true. Surely someone Code Enforcer or all of the business owners in Town is not being truthful. Whatever the case, let's get it together folks! What's the point of having a wheelchair accessible bathroom in downtown's new diner, if a wheelchair user can't make it into the diner in the first place? Encourage existing businesses to increase accessibility. Who knows businesses may start to experience more success 4 more people could get in!
- Combine police/fire rescue facility with neighboring recreation facility is needed!! The teens resort to the YMCA in Concord. they need a place to come together this would keep them out of trouble.
- Comment for #34 Get the other towns out
- Common sense in planning with an idea of the costs (taxes) now and in the future.
- Compared to often towns, our taxes are very high. Why is that?

- Competent persons in these positions ___ make tax increase unnecessary. Persons must emphasize the fact that whatever they do regarding the Master Plan they must take into account the property owners. Cannot be burdened with continuing exorbitant tax rates.
- Consider traffic issues on Pembroke St. Crossing it is almost impossible on foot difficult by car. Look at some kind of a by-pass to move traffic off Pembroke street esp all the commuters going to Concord etc.
- Continue trash pickup by the town-taxes are for school expansion. Charge other towns accordingly.
 Question 34- Pembroke has plenty of buildings for schools use them properly and we will be fine. 29-we need full time Police and Fire Dept. This town is growing so should the protection services. School scores need to improve.
- Control Residential Growth- Slow it down.
- Control the growth of building new homes, which in turn will help to making planning the growth of the town facilities, schools etc, over the next 10 years.
- Curb cuts should be required in future subdivisions. Pembroke needs to get a grasp on its tax base, with the amount of new construction, the tax rate should be a lot lower. The services are very poor for the amount of taxes we pay. Town administration needs to do a top to bottom evaluation of its administration.
- Current town manager has got Pembroke in total disarray. Total lack of any common sense in guiding the town. GOT TO GO!
- Decrease tax rate by adding additional taxable development. Additional roads through Pembroke to lesson Route 3 traffic with commercial development along these new roads.
- Develop upper portion of Pembroke Hill Road.
- Develop White Sands for residents only.
- Do not increase taxes!
- Driving on Route 3, Pembroke does not look like a "town" nor is there any apparent place to stop and eat- perhaps better signs for Suncook Village should be visible. Pembroke has very few appealing properties, ie convenience to stores etc. A major grocery /videostore etc. would benefit not only Pembroke- but also bring in Allenstown, Loudon, Epsom, etc (people who prefer to avoid Concord). Antique dealers would also do well on the major routes, and they wouldn't be an eyesore like the "light" industrial currently on Rt. 106.

- Exclusion of non profits in CI, SRD, Lo and B2 totally. Revisit all fees ie., site plan permits so that fees
 cover salaries of planning director and building inspector plus cost. Update impact fees to be in
 compliance with state RSA. Modeled after Concord's to be fair an equitable dependent on square feet
 and not flat fee.
- Existing homes on unmaintained roads should be taken over by the town.
- Expansion of fire department to include emergency medical response to support existing Tri-Town service. Expansion of fire department to include north sub-station. Start planning now!!!
- Facilities recreational, and organizations for elderly. Need for sidewalks/esp. in village area street lighting.

- Feel strongly that voters should be able to decide on a residential building permit freeze until Master Plan completion. Feel parents should have more say on school issues and schools needs to be held much more accountable for actions and outcomes. Sorry not Master Plan related.
- Find another source of income and lower taxes. They are amongst the highest in the state.
- Focus on commercial and non-family such as elderly housing residential development- retail office parks etc. To increase Pembroke's visibility tax revenues and business activity w/o increasing the costs for additional serves unnecessary. Pembroke's location is excellent we should capitalize on it.
- From what I've heard this town is severely mismanaged. From the town administrator to the schools. Why do we need 2 people (principal & vice prin) at the middle school which has, at this time, low enrollment. The private sector can't afford such luxuries. It's time to clean house.
- Further development to river waterfront including electrical and water supply.
- FYI I moved here from Manchester to live in a more "old Manchester" town. I have found Pembroke to meet those needs. My hope is that Pembroke can manage to grow in a way that helps the town to stay and become more efficient, without losing the qualities that it has now.
- Get a grip on the school budget! There spending habits are out of touch! Run the school like a business not an endless money pit.
- Get taxes in line with other towns the size of this town. Give senior citizens a tax break by reducing the rate for them to stay in their homes. Provide assistance to property owners whose property has been damaged by snow removal sidewalk vehicles the town uses. For example, Pembroke St. residents have had walls (retaining) built but others in downtown have been ignored.
- Give all authority back to municipal fire, police, sewer and water managers. Let them live with there
 budget. Fire town administrator, he has not saved the town any money. All he does is spend, spend,
 and spend.
- Greater financial accountability of all departments.
- Growth is out of control! This is the worst I've ever seen on maintaining the roads in winter!
- Have a public building permit bill \$25 per year. 3 Selectmen, age limit not older than 65. Remove
 administrator from his position, hire a manager at a permanent salary (no extras). Invite a bowling alley
 and pool room downtown to help businesses and create people to go to restaurants etc., something to
 do year-round.
- Have lived in Pembroke for 12 years. I hope that development does not ruin the small, New England town character that attracted us to this community. Both my wife and I plan to retire in our present home. I hope that future tax increases do not force us to leave the community.
- Having just moved to Pembroke within the year- main attraction was its rural charm. I think the
 increase in housing developments is a sad state- there are more than enough houses. Putting tax
 money/donations to work increasing what we have is what I would support. We have a great parkmake it usable! We have roads, fix them to make them drivable (even in winter).
- High property taxes limits virtually any improvements to be considered. Look at other towns with lower taxes and more or better services to see how they do it. It is no honor to have the 5th highest taxes in the state! The town also enjoys one of the highest drop out rates (high school) in the state.
- How about a town-operated store/dinner/coffee shop/etc in where all the profits go back into the
 town. Until we have a strong commercial tax base I would like to see a slowed to zero growth in
 housing developments that are increasing our population and tax rates. And postage-size lots have to
 stop.
- I believe a large portion of our high tax rate goes to education. I understand that out school system is used by some neighboring towns. I hope are paying their shave.
- I believe property taxes need to stabilize. I realize everyone always think they are to high but I believe we need to stabilize them some. Let's stick to the basics. Good schools, good roads, police and fire safety and maybe try to slow growth to help alleve the school crowding problems.

- I believe that it is very important not to develop the Range Roads area it is all there is left for recreation in Pembroke
- I believe that town priorities are mixed up because I think that if the Police/Fire buildings were so bad why did we put in a library first? I also think that Donna Drive is a flood zone and homes should have never been built here without storm drains. There are drainage ditches here and there but the water does not go there, it runs across people's driveways and lawns. The water stays on the road n most places causing cracks and other damages. Most yards in the Donna Drive area should be considered wetlands and tax rate adjusted to a lower rate. Driveways cost a lot of money too, but not for the town, the homeowner.
- I believe that we should try to maintain are taxes to discourage an increase. It's very important to improve the sidewalks in the village school area. Maple St. sidewalk are very dangerous to all person. Kids need to be safe and not walk in street because maintenance of sidewalk is poor (snow removal does do a great job in the winter though)!
- I believe the Town & School budgets have been reasonable and quite often frugal however the tax base i insufficient to generate enough revenue. The burden falls to single families with limited income. More revenue needs to be generated by business. I believe we need to let go of our restrictions on business development along the Route 3 corridor. We have the traffic but the money goes to Concord & Hooksett. There has to be a "Happy media" between no business on Route 3 and Manchester Street Concord or Route 3 Hooksett.
- I believe the town of Pembroke provides good school & support services considering our town lacks the land to support tax-based business/industry. The tax situation supports our bedroom community atmosphere & lifestyle.
- I believe the use of taxes should be investigated. There is misuse of taxes in this community. There is no reason for the tax rate to be this high in a town so small with very little to offer. Check the road crew and how they use the money to plow roads ex: plowing of roads during a 1-2 inch snow, why is this being done? Library- this building was built illegally with money. STOP THE WASTE NOW!!!
- I believer we need a new police station but not now we have been overburdened with taxes. Too much on our plate for now!
- I BELIEVE THAT TOP OFFICIALS SHOULD BE LEGAL RESIDENTS OF THE TOWN, NOT BEING A RESIDENT WE DO NOT GET ANY TAX MONIES BACK. IF THEY DO NOT LIVE IN TOWN HOW CAN THEY JUSTIFY WHAT THEY CARE ABOUT, JUST DO WHAT HAS TO BE DONE AND GO HOME.
- I don't feel budget cuts should come from school budget. That's the last place they should come from!
- I don't know how, but we need more businesses, or other entities that would pay property taxes, but not 'tax' sensitive town services. I'm guessing offices, commercial buildings & elderly housing wouldn't send kids to school so those come to mind. #35- Same. I'll Pay more.
- I feel strongly new home building permits need to be limited. We cannot support the number of children in the school system these homes bring. Our tax rate is increasing faster than any others and faster than inflation -vs- salary increases for most folks. We are seriously considering a move strictly due to the tax rate.
- I feel that there is too much building going on. Soon there will be no more forests, animals, or open spaces left. Also, all this building is causing too much traffic and overcrowding, not to mention pollution. I'd say limit building.
- I have been living in Pembroke as of August 2001. Since then my property taxes have been increased 3 times. The town better start getting some businesses in here or expand the zoning areas for more commercial purposes otherwise your going to make a lot of people move out of here.

- I have lived in Pembroke for the last 13 years. I was raised in Allenstown before that. This year I have decided to sell my home because I do not feel what we pay in taxes, and the services that we get are worth money anymore. Pembroke is out of control and the ones we are hurting the most is our children because that is were we are forced to cut money from the system.
- I have lived in the town of Pembroke almost all of my life and I look forward to raising my daughter
 here. I would like to see the taxes lowered so that one day I may be able to afford a home for us instead
 of renting.
- I have read other towns tax rates and plans for their community are exactly like ours. However, they can operate on a lower budget without constantly increasing the taxes. I just don't see why we are at such a higher rate than most towns with so little to show for and the town officials are still crying help. Maybe we should cap salaries to lower taxes?
- I moved to Pembroke from Concord last year. It's hard to believe that the services here are worth \$1000 to 1500 more than the Capitol City. Yet they are! Where are the extras? Don't try to tell us it's because they have many more churches and state and federal businesses that pay nothing in taxes. There should be no tax increases for at least 5-10 years. Have any of you noticed the economy lately? It's not getting better!
- I personally feel that trash pickup for the tenants at Ashley Park mobile home on 235 Dearborn Road should be considered. - I see new houses being built everywhere, while at the same time we have four schools already and hear about them being overcrowded. New houses means more school age kids- that impacts schools, rubbish pick-up, plowing, police dept, fire dept, water, sewage, etc. I am not so sure encouraging more houses to be built is the answer.
- I support a two acre limit on future single family homes. Our schools and the quality of education is the primary reason we moved to Pembroke. We love the "small town" feel that Pembroke has and I'd hate to see it get overdeveloped with Condos apts. trailer parks. I'd like to see the master plan attract the upper-middle class and limit the growth in this town. Thank you for the survey.
- I think Pembroke's priority should be to attract businesses to help our tax rate. We should also pursue a growth ordinance. We need more business and not more residences.
- I think sports activities should be totally funded by parents and not taxpayers as a whole. If the Town is looking for a place to cut expenses put that burden on the parents of children wishing to participate and not cut books, teachers or education supplies.
- I think we should consider looking for new Town Managers. I don't believe Dave is doing a very good job. In last few years. I think he could be doing a lot more instead of hiring more people to do what he should be doing. I think he has been here to long we need someone with more drive and new skills. I have noticed the way he answers people questions at Town meeting. He seems to be saying just trust me.
- I want a tax decrease. The services in poor condition are poor because they are highly mismanaged not because more money is needed. The taxes need to be cut dramatically. All town related employees should be residents of the town. There needs to be better disclosure regarding all aspects of all town related functions. - I would like to see our parks maintained better. As a parent who has children in sporting events it is embarrassing for towns with nice fields to come here and play on unmowed dirty fields.
- I would like to see positive people on boards with no personal agendas.
- I would like to see town forests off limits to motorized wheeled vehicles and open to only hiking,
 horseback riding and maybe bike riding. Beautiful trails have been destroyed by ATVs in the Upland
 area, making them unusable for walking and horseback riding.
- I would like to see Town water extended to Deerpath Lane (and other densely populated areas not currently covered). well water is, at times, a potential problem I'd prefer not to be bothered about. A serious traffic control situation exists at rt3 and Pembroke Hill Road especially in the 745-800am. A really simple solution (at minimal costs) would be to assign an officer to this intersections each morning during the week when school is in session. Someone is going to be hurt (or worse) due to this hazard! xxxx xxxxxxxxx xxx Deerpath Lane.
- I would like to see us develop a more involved recreation department and expand the parks... Especially
 for younger children...playground equip for toddlers
- I'm not sure this belongs in the Master Plan, but I felt the need to voice my opinion. I was delighted to receive this survey in the mail today because I often feel removed from the town. Both of our routes to work don't bring us through the center of town, the town website is not updated and seldom is there significant information in the Hooksett Banner to keep me up to date on the town events or interest me in becoming involved. If we didn't have a beautiful 4-acre lot and a new house in this town, I'd consider moving. Working in Plymouth I am witness to a town with a real sense of community. Everyone knows everyone else and there is really just a sense in the air. I don't know how to describe it except to say it's a sense of community. We have lived here for three years and I really can't say we have any friends in this town. Where are there opportunities to meet people? It seems like whenever there's an event going on like a Christmas fair or Old Home Days I hear about it after the fact. I think the town could do a better job of communicating the community events. When we lived in Florida and were researching places to buy land I had the misconception that Pembroke would be a great small town community. I think the small town part is still accurate but I'm not convinced of the community aspect. The town also needs to make a better effort to attract and retain businesses to help offset the tax base. The town is not going to improve on residential taxes alone. If we could attract some more businesses in the appropriate areas we could really benefit from the added tax revenue.
- If centralization of service departments is to occur, the supervision (or head) should be done by the Town Manager. We cannot afford to create a new layer of expense. Give the Town Manager something of substance to do. Eliminate the term Suncook. I pay taxes to the Town of Pembroke not Suncook. Our Town Clerk admitted to me that there is no such place as Suncook!
- If taxes continue to increase. I will have to move and no longer enjoy the services amenities Pembroke has to offer.
- In order for Pembroke to become more than a bedroom community to Manchester and Concord, we need something to define us. A unique festival, a well developed historical district, a fabulous school system, something. As it is there is no reason people choose to move here, it is merely a choice born of affordability or accessibility.
- In order to cut/reduce tax burden to residents an increase in commercial development should be considered. Where it should/could be permitted is always difficult. Most people don't want it in their back yard. I would think that persons seeking a location would desire easy access to main traffic arteries. Possible areas of commercial in order might be route 28, route 106, and route 4. Question 18 they are already small enough in our area Bow lane. Question 21 residential, modify 125' set back restriction. Question 39 current problems at town offices must be resolved and accounted for prior to commenting.

- Increase board of Selectmen to five members. Provide some minimum maintenance to Range Roads (which is subject to gates and bars).
- Increase lot sizes for residential building permits. R-1 to 1 acre minimum; r-3 to 3 acres minimum.
- Increase voter registration and participation as a community.
- Instead of building new fire station extension/combined police station, use present new library.
- It is not necessary to house police and fire in the same complex. Keep multi-million dream projects at bay.
- It is sad to think that after retiring I will have to leave to rent in an area with a more attractive tax rate
- It was brought up at the town budget meeting that there are several issues (repeatedly) with xxxxx xxxxx. He was questioned and unable to answer specific questions about the town budget. It was also brought up that town members are not comfortable paying for his MBA or high insurance rates. Also, there is not adequate planning for new construction. There are ways around allowing developers to build large developments that will cause high taxes (high school costs) and more road costs not to mention detracting from the rural nature of Pembroke. How many "Donna Drive" developments do we need?
- Just some thoughts ... consolidate Hill and Village schools by expanding Hill school. Hill school would become grades K-4. Village school can be remodeled and made into a police stations which would offer much more room (and a gym for working out). Renovate the police station into a rec center for the elderly or youth. Bring the CAT to Pembroke, which would encourage seniors to get out and become more involved in society and the community. Supporting four schools in town with such a small population is ridiculous. By eliminating one we've cut the budge considerably. I don't think Pembroke has its priorities straight, the people just want a place to blame and not accept responsibility or change.
- Keep curb-side trash pick-up. If the town fire department and police department are in dire need of updates, pick the cheapest plan to fix it, if it isn't necessary stop raising our taxes. Bring in businesses to help control tax increases. Our taxes are getting too high.
- Keep open space. Take a closer look at how all your residential housing growth has impacted tax rate.
 Do not allow zoning variances for cluster developments!! No more Wellington Ways. Don't waste tax
 dollars dancing around the issues "planning" do something or nothing. Change town motto from
 prosper in Pembroke to "Poverty in Pembroke".
- Keep the small natural areas preserved by the town for all to use. The small pond area on Brickett Hill Road is lovely, however it is poorly maintained and vandalized by ATV users. Signs destroyed and trails rutted
- Let the people of the town manage their own town and property. Tax cut for those that home school, and that pay to send their children to other schools. It cuts the cost of the public schools.

- No more cluster housing, It causes growth problems and Quality of life is not as good.
- Obviously if we wish there was curbside recycling as part of the trash removal and increased recreational programs.
- Obviously, growth is a continuing problem. We can't stop it, but we have to carefully monitor it's effect on everything around it-roads, runoff, school population, etc. You don't just build one or two houses in a neighborhood & it stops there-those two (or 12) homes have a ripple effect- we have to move forward carefully.
- One small thing on this scale, but a big very important think to my family, and others: I live on Grandview Rd, next to the end. There's a small, narrow piece of wetlands (marked as such when surveyed + flagged) between my back property line, (and neighbors' also) and the same lines behind Deerpath Lane, a horseshoe street up Pembroke Hill Rd. from us. I'm very concerned that nothing is built back there, for 2 of many reasons: Wetlands, too small, and it would mean a road going into it where there's not enough room! Also: the way it's shaped, it becomes a wildlife sanctuary from deer during hunting season (too close to houses to hunt) to wildlife of all kinds year-round. It would be WRONG too cramped for N.H., and greatly hurt me and mine.

- Operation budget is out of control compared to similar size towns. Services do not match tax rate.
 Town administrator should live in town. Very questionable finance transactions over last few years.
 Positive note: at least you hired a finance director.
- Our schools should concentrate on the academics more than all the sports. Each year they want the
 taxpayers to pay for a new sport -tennis-golf-hockey-skiing-hockey-football should be at the expense of
 the parents. Enough is enough-our town is known for its taxes. Our slogan will be changed to "Go
 broke in Pembroke" if it keeps on!
- Outlaw existing & new trailer parks and down size school system (multi town use).
- Pay enough taxes now!
- Pembroke is beginning to look like a junkyard. Too many unregistered vehicles in yards. Too much trash in yards. Last year town newsletter said "items on person's property for sale had to belong to property owner and could only be offered for sale for 2 weeks." This was never enforced. Please clean up our beautiful town (esp. Pembroke Street area). Walk on sidewalks and learn how badly they need clearing.
- Pembroke must bring in businesses to support our high tax rate. We can no longer afford "small town" thinking with "big town" taxes. Our kids need good schools and the town deserves good services; but they come with a price. More businesses in town and FEWER single family homes with 4 kids will help all of us pay our taxes!
- Pembroke needs affordable housing !!
- Pembroke needs to treat business more fairly. We are taxed at a higher rate than a residential yet we can't vote, or use the transfer station, or use the school. We should be taxed at the same rate as residential (even though we're not allowed an Town Services) Give businesses something for their 'buck'. How can you expect to retain businesses or attract new ones in this unfriendly business environment??
- Pembroke property taxes are TOO HIGH that why we are planning of moving out of Pembroke.
- Pembroke's taxes are some of the highest in the state...what do we have to show for them? it has a wonderful rural area but too many dirt roads...they are terrible to travel on when wet...we need more industrial companies to subsidize the tax base.....taxes are way too high!!!!
- Pertaining to question 39 Why do taxes have to increase yearly? Everybody does not receive a yearly coat
 of living raise.
- Planning and master planning must be done within a regional context. we are not an island.
- Plant trees near the sidewalks and encourage business owners to dress their places up with flowers in
 warm months. Do more decorating on the holiday. If the town and village is a cold stark place when
 people drive thru why would they want to stop. This is where pride comes in. Also if you see groups of
 teens hanging in front of businesses you may be afraid to stop and shop. Good restaurants even a good
 chain would be better than nothing. Not fast food.
- Please clean up of downtown streets, buildings, front street has trash everywhere. It looks alot like the ghetto. It didn't look like this 30 years ago! Double parked cars on streets, blocking of entrance to streets, driveways, downtown areas becoming a problem. There is no respect for people that are homeowners and have lived here all there lives, it's turning into a messy town. Needs a lot of cleanup.
- Please continue to monitor development that would add traffic to Pembroke Hill, It is so difficult to get
 on to Pembroke Street. Obtain land for expanded recreational fields, school fields and Memorial Field
 are maxed out. Add recreational services for children they are practically non existent. Develop a plan
 to manage growth soon! xxx xxxx is very helpful! Thanks for all of your hard work.
- Please investigate town administrator for possible wrong doing with funds. I would like to know what to 3 million dollars.
- Please limit future growth. We don't want to live in a Boston suburb. Keep the town small and try to maintain and attract lucrative businesses to town.

- Please, please, please- no more development on Route 3 like has already happened. #300,000 cluster
 housing on what had once been beautiful scenery is not the answer. It is a short term fix of cash from
 property tax, but a long term loss of quality of life. We are becoming Concord. I want to stay here in
 Pembroke but you are destroying it! If the parents want kids, then tell them to pay up the \$ and stop
 ruining our city with development.
- Poor road condition on the dirt section of Pembroke Rd.
- Preservation of Wetlands and forests and overpopulation
- Property taxes are excessive!
- Property taxes have gotten completely out of control. Roads are in disarrear. Town planning should be
 projected out many years possibly a full generation. You can't build homes roads businesses etc.
 Without factown in school, sewers water etc.
- Property Taxes must be reduced!
- PSNH is a horrible electrical service provider. I would like to see unitil or other options. I'm tired of paying more fees than electrical. I used.
- Public development along rivers should be promoted. If school expansion was necessary expansion should be existing school to larger capacity or small additional schools on existing campus.
- Public transportation to Concord and Manchester. Seniors transportation to local groceries and health care. Low income housing.
- Q21- If happened, we would destroy our Town. Since I have lived in the Town of Pembroke we have
 had our address changed 4 times. Growth means more expenses problems the taxes we get from the
 300,000 Home is not enough to cover the 3-4 children they have to go to school. Contractors are only
 concerned about their pockets not the towns. No interest in the town and how we already have spoiled
 our area
- Question # 34 eliminate tuition students from other towns to make room for our own.
- Question #15 no houses until we have more business to offset taxes.
- Question #15 We don't know what exists now.
- Question #19 Pembroke for school and home otherwise with 8 children we found ourselves taking kids to Manchester or Concord on multi-lapped schedules for recreation.
- Question #39 Can't suck much more out of us property won't be worth anything if the retax is unreasonable!!
- Question 25 Not enough control over noise and the destructive aspects of ATVs and snowmobiles. Walking trails for people, canines and equines. Question 39 I think we should re-evaluate how our present tax dollar is being used and put it to the most effective use. I do think we need the expanded joint police and fire facilities. In NY state, property taxes are reduced for senior citizens. Seniors do not add expenses to the school system which is one of the big bites to the tax dollar. Seniors can be an excellent source of volunteer help in schools, after school activities, library. Seniors are good citizens, have contributed to the community and should have taxes reduced so they are not forced out of the town because they can no longer afford to maintain their property. And, we are all getting older!

Over-development of housing in Hooksett has put a burden on taxpayers already residing in areas ie. expansion of all tax paid services to accommodate over-development. People need space and fresh air. Don't do this to Pembroke. Pembroke is a gem of a town. Don't ruin it.
- RE Taxes are out of control. No reason to have highest rate in State. Should not stop development. why should Bow have new housed in the 1/2 million dollars range and not Pembroke? Recent new houses have been in the \$200,000-300,000 range, let's keep them coming.
- Recycling even a drop off would be great.
- Recycling is a huge priority!! Don't shelve the idea!!!
- Reduce adm. school salaries as i feel they are too high and may take away from funds needed to run
 other
- Reduce residential building starts. We need to increase commercial/business activity.
- Reduce size of town government, too many people making high salaries.
- Repairing Broadway Street. The street is higher than the sidewalks from Pine Street to Main Street. Especially bad between 10-24 Broadway. House shakes when heavy trucks pass the apartment.
- Require lower lots for home building permits; r-3 to 3 or 4 acres; r-1 to 1 acre minimum; Question 12 north upland and areas along Merrimack river
- Residential growth limits are important in order to protect our tax rate. Children are very expensive to educate. Zoning of areas are important to provide areas of non residential growth. To clarify the intent of use of that land. I find it unfortunate not to employ an independent CFO to oversee the town and schools appx. 22 million dollar business (in business, not government capacity). Tax increases should be limited to the average salary increase of its residents. I would also like to see taxes collected more frequently to eliminate the appx. \$200,000 in loan interest.
- Residents who choose to have their children at private schools should have a little bit of a tax break on the school portion of the town tax. The elderly homeowners should be removed from being assessed the school portion of the town tax. The new HUGE library should be used as a police station-there is no need for this library of this size when most households have internet access. We have 3 children and never need go to the library -2 of them are avid readers!
- School Budget way out of Control

Traffic light at the junction of Route 3 and Pembroke Hill Road. Purchase of easements to allow for expected growth of infrastructure.

- Should issue a certain amount of building permits a year. There should be less houses being built in a
 vear.

- Someone has got to step up and say enough is enough on taxes. Unless this Town can draw in some big business to help with taxes instead of building new houses we will never make it as a Town. We need to lower the tax rate as it is the highest in the State of NH.
- Stay in budget. Childrens' projects shouldn't be downplayed since they will be citizens of your town.
 Voter-knowledge and information to know what they are voting on in plain english- Banners that alert town people when meetings are. Issues on Bulletin Boards at Post Office and band and bi-wise.
- Stiffer penalties for people who let their dogs crap on others lawns daily!
- Stop building on 1/4 to 1/2 acre of land.
- Stop the feeding of ducks and geese so they will move on instead of multiplying.
- Street light at Pembroke Hill Road, utilying red/green light between 7-9 a.m and 3-6 p.m. yellow blinker between these times (traffic backs up as many as 10-12 cars during busy hours)
- Stricter enforcement of town ordinances -if you're going to pass an ordinance/law enforce it! (wrong way streets; skateboarding; parking in municipal lot; speeding; parking on Route 3 in front of "No Parking Next Mile" signs to do yard-saleing; no right-hand turn on red at top of Broadway; unregistered vehicles on public streets-municipal lot; lease law; dumpsters left to over-flow (smells to high heaven in warm weather).
- Suggest people pay a small fee (\$70/year) per family, for a dump sticker and trash pick-up rather than not having it or going to private pick-up. Taxes paid 2X/year.
- Summer activities, town pool
- Suncook Village is great but needs some TLC. Can some white collar businesses be located there. The
 Town needs to preserve historic buildings, and more farm and forestland.
- Support better emergency services. Support teacher salaries and updating school facilities and material.
- Survey seems to be weighted toward spending more, not less, i.e. "The Town should"
- Survey too long.
- Tax collection-Twice a year with three months notice to make payment. Veterans should not have to submit paperwork, for their \$100 discount, each year. It should be a one time procedure. Liens are too easily placed on property. A friend of mine paid his taxes minus the \$100 veteran discount and, rather than a call or letter to remind him he needed to resubmit his paperwork, a lien was placed on his home. That is no way to treat a veteran. Town employees-Slightly higher pay reduced benefits especially in area of retirement. Their jobs should be more about serving their communities and not about the benefit package. For them to ask for bigger increases to make up for less last year plus more for their retirement plan is simply pure greed. Let them find employers in the business world doing those types of things. They won't find it in this area. Most businesses are cutting benefits and limiting pay increases to 1-3 percent. Development-Better determination of priorities and requirements. A fire/safety complex is much more important than a library or adding football or hockey teams. Also have more than one plan for voters to look at instead of continually asking for the moon in year one then cutting back some the next proposal the next year. If the current library design had but put through the year the original proposal was shot down imaging the money that could have been saved. Even now the library is excessive. It could have been a more simple less ornate design that started off a little smaller but had a design that allowed for additions to me made over time. If the fire/safety complex is voted down blame the library. I don't remember the gentleman's name but the person who handles the registrations at the town hall is one of the most courteous people I have ever worked with in town government. A few people in our town hall could learn a lesson from him in serving the public

instead of acting like them public owes them. School board-The list of proposed cuts should have been mailed to townspeople in advance to get a better reflection of what were the higher/lower priorities before actually voting on them at the meeting. I'm not saying more people should not make it to town meetings but sometimes a survey like this one is a better forum for input. Remember what we are. We do not have the revenue to be Concord nor should be want to be. Being a small town is not a bad thing. It's why most of us are here. FYI whenever I tried to click on an answer for the first column of question 20 it removed my answers from the first column of question 19 and vice versa. Sincerely xxxxxx xxxxxx

- Tax rate is too high. Additional tax increase discourage growth (Businesses as well as residents. Preservation of charm, quality services, accolades are due.
- Tax rate! Can't we (town) face the amount we change other towns to send their children to our school system? Tax Rate! When you have for example a 5 unit apartment building owned by one person does the town collect 1 tax bill based on the assessed valve of the building? If so, what happens when each of those units have 1 or more children going to the school system? So from 1 building you collect 1 tax bill but 5 or more kids can impact the tax rate? It seems like a lot of people are moving out of this area and older seniors can't afford to live out their lives in the homes they started in?
- Tax rates need to stay steady for several years. Increases year after year cannot be tolerated
- Tax reassessment of homes in Pembroke is long past due (several years past due). I do not feel this is fair to new homeowners. Must we be forced to pay higher rates than older dwellings in this town?
- Tax reduction initiatives!
- Taxes are already to high.
- Taxes are already too high. The only reason we would move away would be to build again somewhere
 with better tax rates.
- Taxes are do high in this town, people can't afford to stay in their homes. After attending many town meetings at P.A. we only see the Town's people attend meetings after meetings only to keep going back and the Board finally get what they want only to bring the tax rate higher and higher. Also, if we can't afford rubbish pickup, or teachers at the schools how can we afford a new police station and fire department? Taxes should be lowered because of all the new houses in Pembroke. Which is not necessary and has ruined our woods and neighborhood.
- Taxes are indeed on highest priority list! If people cannot afford them, they will need to move elsewhere. My husband is retired and I'm the only one working. We have no children as dependents anymore and are therefore in a higher tax bracket. We've lived here for 30 years, however, are now on fixed incomes and our taxes are nearing \$4000 year (almost becoming unaffordable to live here). Tax collection- need to keep paying annually, not semi-annually. Because we have no dependents and to qualify for long form IRS taxes, we pay town house taxes and group them every other year so we may qualify for long form on Federal IRS taxes. Growth-need to immediately stop the insane growth in town! More new homes mean more town services demands and more importantly more children going to our schools! We need to change building requirements to no less than 5 plus acre lots and limit the amount of building permits issued annually! Thanks!
- Taxes are sky high in Pembroke- they have averaged 1.00 increase/thousand over the last 5 years. The elderly and low income are suffering. You need to use the money you have that we (taxpayers on 2 properties) give you much wiser and frugal. You can do 100% better with what you have if you really want to. When a town meeting is held and the articles are with an undetermined amount for your request, this is very poor. We do not in our household ask for an item (new car, furniture, etc) and say I think it will be this much, we shop first and find the item then allocate the funds! Administration and selectmen serve the people of Pembroke and need to be accountable for our money. The last thing our town needs is a new school- stop attracting house buildings and concentrate on industry, commercial, (tax alleving) buildings.

- Taxes are too high already maybe town could just maintain services if no money is available for new services
- Taxes are too high as it is, keep taxes down; stop residential building to many new developments. Our schools and roads cannot keep up with all these new people. Traffic is becoming a huge problem.

Regulations should be enacted to discourage families from moving to Pembroke solely for purposes of sending their kids to school, then moving away from town when schooling is done. This place extremely unfair tax burden of life time residents!
- Taxes have to be contained if the town wishes to keep its diverse population and not become another Bedford community.
- Taxes in Pembroke are outrageous for what the town offers. Many things such as a large bank, large grocery store, video store pool activity center and needed to supplement. We moved to Pembroke thinking we were going to get the best of both worlds Concord & Manchester unfortunately we pay higher taxes than both.
- Taxes in Pembroke are too high. I can hardly believe this question is asked in this way.
- Taxes need to be lowered-First Priority
- Taxes should be increased a minimum of 50%
- Taxes to high as it is
- Taxes too high. Need businesses.
- Taxes, taxes, taxes too high library was a mistake.
- That motorized wheeled vehicles be limited to May-Oct on Range Roads and town trails. This will prevent major damage to these roads and trails so that they would remain usable for all activities.
- The air and water pollution is outrageous! Speaking to scientists studying our air and water in Pembroke and also diff environmental factions they have produced info and figures showing there is growing concern and high incidents of lead, arsenic, and mercury levels in our ground, air and water here. This pond just between Pembroke and Allenstown is highly polluted and should be labeled as such for no fishing or swimming. Just look at the deformities and mutations the geese have that live at the pond! Being is the medical field, I am also well aware of the high bad levels of our Pembroke children especially ones that live near the pond. These are children that do not have lead in the homes but still have high lead levels.
- The amount of funds that surrounding towns contribute which use Pembroke's school system. I feel that one reason Pembroke is faced with one of the highest tax rates in the state, is due to the fact that we support a Senior High School with a low or small tax base, I feel surrounding towns are not paying their fair share.
- The arrogant attitude of this town's school board is unacceptable and needs to be addressed. The school budget needs to be changed to allow the voters the right to vote on each item and not be forced and intimidated into having the school board's priorities thrust upon us. I am deeply concerned about the elderly community in Pembroke and all Pembroke residents, who due to the economy, have lost jobs or been restricted in pay. What is paid in taxes is not giving the resident's their money's worth.
- The biggest issue that needs to be addressed is that of economic development and lowering the
 currently high tax rate. The town needs to attract commercial businesses in order to increase the tax
 base and lower the burden on residential areas.
- The communities of Pembroke, Suncook and Allenstown should work together for the good of all towns. Several issues that arose in the past year or two give the impression that town officials are working against each other which has a negative impact on the towns and residents.

- The Master Plan should be simple- Do whatever is needed to reduce our tax burden. Who cares about recreation, when they can't afford our taxes?! Let's get back to basics people cut taxes- we live within our means-so should the Town of Pembroke!!!
- The new subdivision at Peaslee Rd is quite attractive. The new subdivision on the corner of
 Whittemore and Pembroke St. is really ugly and takes away from the towns desirability. Maybe more
 attention should be paid to proposed subdivision layouts.
- The next major issue which should be addressed is a town recreation facility. People pay \$800/yr for a family membership at the YMCA, not to mention gyms. The town facilities would be more convenient and probably less expensive. Children should participate in activities with our town and not be forced to turn to other towns. 2. Considering we are new to the area we were disappointed to learn that we do not have public water on Deerpath. 3. No recycling program! No hazardous waste program = dumping in normal trash. 4. One of the primary reasons we moved into Pembroke was because of the school system. We hope the schools reductions do not erode the quality of education. 5. Disappointed winter roads were substandard compared to other towns traveled each day to work. 6. Town needs to work diligently to balance the needs of a greater tax base and the rural character of the town. 7. Need for some traffic lights on route 3 on the side streets (esp. Pembroke Hill) during school traffic times and rush hour.
- The school at Village being shutdown and the Pembroke Hill School becoming a K4 school.
- The school system leaves little to the parents. Teachers are inaccessible-unwilling to give out phone numbers or emails/parent opinions are often discarded with "people don't want to know t hat". Communication from the schools is abrupt and unreliable. There are never the special plays or assemblies to see the elementary students in. Instead of an open and honest relationship the administrator fosters a guarded and defiant relationship.
- The survey seems to written to get answers someone wants not questions to what people might want especially dealing with schools, trash pickup, and other programs. Survey only gives the committee's choices and does not allow for other choices. So with this type of survey you only get the answers you want even though people filling it out do not agree but answered because of their limited choices.
- The tax rate is 5th highest in state, something is wrong.
- The tax rate is driving out and turning away residents and businesses. Monies are not being spent or cut wisely. Justify building a safety complex and taking away teachers and activities that keep our youth out of trouble and compatible with other school systems. Our youth should be a priority.
- The taxes in this town are out of control! Raise tuition for other towns to send their children to our schools it should cover the actual cost not a percentage & some for administrative issues. It will still be cheaper than building their own school. Also, slow residential building. Our school system can't handle the influx and we cannot increase taxes anymore. There should be at least 2 acre minimum. Finally, we need a better tax base more retail. We need to attract retail!
- The town is growing out of control. Taxpayers can barely afford to provide for the number of children being educated in the school system now. What happened to the committee looking into limiting the number of building permits given each year? Also, a lot of people who support the large portion of the taxes that go to the school do not live in the upland area. They live on roads that are always plowed, some are maintained by the state. We pay the same tax rate as these people, but we are always the last to be plowed and sanded. We can't even get out of our driveways to get our children to the bus stop or drive them to school to begin with. Why do we have to pay the high tax rate and not receive the same services as the people who live in the more populated areas? I guess this is why we feel more money needs to go to the town and less to the school. (I also hope that the fire and police departments can have their new buildings soon. They sure do a lot for us.) We have children in the school system. We would much rather help pay for things as they need them for school during the year, such as sports and supplies. Things need to be changed so that there is equality for all.

- The town must increase the business tax base that means new business, not increasing existing! Signage must be taken into consideration. It will do no good to bring business in and then not allow signage. The town needs to make a pro-active, public campaign to get businesses to look at us. While I am in the hotel business I do not see a visible place for a hotel we are too far if the 93 track to have it make sense. The town needs to figure out how to legally slow to a crawl. New housing, until it can figure out how to boost business tax. Residential tax is out of control and services are being cut. The school district is suffering and that is most unfortunate. The only way I see to help out is with increased revenues.
- The town needs to focus a centralized town service area NOT on route 3 but centralized to the majority
 of the population. Residents should not have to drive for town services while the increased traffic
 patterns slow that drive.
- The town of Pembroke is out of control as for as taxes go. If something isn't done to control the constant increase there will be no money for these things you have listed here in your "master plan"
- The town of Pembroke must expand in two areas to better serve its citizens. Parks and recreation and
 institute a local access cable to station. Cable local access would bring municipal school meetings
 directly to the Pembroke public. This would create a better informed citizenry and also serve to unite
 us.
- The Town of Pembroke will grow, and the time to plan is now. If we want a residential quality (in mixed incomes), some development in this area should be encouraged. As for business development, do we want another Rte 2-28 in Hooksett? (no!) If additional residents move here, Pembroke may need an additional artery (n-s) besides Pembroke Street. Hope is to plan for residential growth. If this happens, some business growth will automatically follow.
- The town's building inspector is not doing a good job. 2 Residents that I know of have complained about a neighbor who has a failed septic system, and the back wash is being put into the wet lands, and the tank is leaking. He was called 3 times on this and our area still smells and I'm worried that it may get into our well. Peter has done nothing to get this fixed. I was told that another resident on N. Pembroke Rd is calling the state to find out why this has been going on for over 6 years, and 3 different owners. This property has no leach field and again has gone through 3 different owners and never got fixed or inspected!!! That is what upsets me about Pembroke, they do not care. And on another note, taxes are way to high!!! No one can afford to live in Pembroke anymore. We're trying to raise a family and to pay taxes as high as they are is crazy. We cannot afford it. Taxes should not get raised. Maybe if they budget the money better this would not be a problem, and do some cut backs of the Pembroke employees. Also if its true that we pay for their benefits/insurance, that should be stopped. They should pay for their own insurance as the rest of the world does.
- The two most important issues is to assure that our town is not destroyed by yet another impersonal shopping district. We need to encourage and support our neighbors and to foster a sense of community. In addition, we need to attract better jobs to this area; there higher paying jobs will attract higher income residents. All of this would contribute to the community. How-paying retail or hotel jobs give no things back and only add to the congestion and degradation of surrounding areas. We need to preserve what's left of the beauty of our area. I already feel that it is vanishing too fast, and that if it continues, I'll be moving.
- The water service and quality are good in the service area.

- There is no public transportation. Though this is also a state problem, public transportation into Concord and Manchester would help teens getting to work, the elderly getting to medical care. There is not a centralized area for the teen population, the schools are helping with sports related activities, churches are active with programs, but it would be great if they had teen centered activity program look at Hopkinton's and Concord's model teen programs. Services are not centralized. I support expanding the Fire Department building to include police dept. We need to provide more support to the police and fire and rescue departments. Please do not cut back on the programs at the high school, education, art and music important. Look at our dropout rate and percentage attending college. Clean up housing by Emerson Mills.
- There needs to be a significant "Impact Fee" increase to all new residential construction. The current fee is way to small. Its very pathetic that the town had to return money to the home owners because they couldn't manage to spend it on the same improvements your questions ask. i.e. recreation, tennis, basketball courts.
- There should be a limit as to how many new homes are to be built per year in the entire town. Every time a new home goes up, that means there are more children to educate, more stress on town services-water supply and sewage. How many times can we expand schools or any of the other things? It's getting to the point where most people can't afford to pay their taxes and will be forced to leave Pembroke.
- There should be recycling!
- To keep growth at minimum. Keep Range Roads closed. It will only add to more growth and more
 traffic problems maybe an new administrator to work for the town. Not really doing a good job!
 Master Plan is fine if you get more people involved. But letting to contractors tell the town what to do
 about how many houses they can build no control over the Master Plan if you let them do what they
 want.
- To much on schools not enough on retired, time to think about senior citizens.
- Too many new houses. Our place is full now. I think we should spend our money more wisely and just say "no" once in a while. If I can't afford to buy something this year, I'll not put it on credit cards.
- Too many renters and low income homes. Glass street is awful looking
- Town services, a.e. trash pick-up, police and fire services.
- Town should be responsible for trash removal, water and sewer, snow removal, school system, road
 repairs. The rest should be done by fundraising in order to lower taxes.
- Town should have the private sector volunteer money and time to decrease town spending.
- Town should limit the building of residential houses to a number per year and minimum lot size of 2 acres.
- Town taxes should only increase based on the annual citizens salary which currently averages 3% a year. Society expects the individual citizen to budget their finances reasonably as the citizen expects the town to. Their are too many town committees, which should be replaces with public should transportation through high school. The town does not support the high school students or parents enough. The town should have all its financial records audited. Why don't banks want to back us financially?
- Town taxes some people can't afford their taxes. It takes every thing they got. Better accounting so that people know where the money goes. Where does the money goes and what its used for. For the renting to churches, we never here about that but I'm sure they pay.
- Town: 1. Poor vision & direction lack results. 2. New leadership-management. 3. Employees overpaid for size of town. 4. 106 project a calamity failed to ease taxes 5. Need cross trail employees 6. Police too many supervisors & smaller vehicles, community policing. Schools: 1. Replace school superintendent 2. Drop out rate too high. 3. Special education reevaluated-investigated. 4. Renegotiate teacher contracts. 5. 80% taxes go towards schools more standards & high results should be required of administrators, school comm. & teachers.

- Transportation corridors to make it possible to travel N&S through town without using route 3
- Transportation for school children and bus stops in a reasonable and safe place. More money to the schools. Demand to the state to pay full special education cost.
- Try to discourage housing developments; try to attract businesses to town; don't let houses go into
 sandpit behind Langs ice cream; from Langs ice cream all the way to Concord should be commercial;
 don't let churches into prime commercial space; try to turn the land along the Soucook into clear
 commercial space, office parks, etc; preserve the vast forest land in 5th and 6th Range Road areas.
- Try to find uses for school property during off season, example- adult learning classes. Fix roads that need it even if speeds increase then enforce speed limit. Join w/ Allenstown to promote both towns as one cohesive community. Bi-wise area could have an information center at old Bank or large electronic community message board.
- Vast growth. Pembroke tax payers can only take so much and the town is growing so fast that many
 cannot afford to live in a Pembroke (Bedford) atmosphere. Its a wonderful town and I'd hate to leave
 because I cannot afford to live here due to increases in taxes.
- Wages are not going up. Social Security is not going up. Yet taxes keep going up all the time. People
 are selling their homes because of the rise in taxes. Elderly people are suffering because of taxes. They
 should have a discount on taxes.
- Ways of voting in the town are near illegal and should be monitored. Town people feel that the library was shoved down our throats and handled badly. What need to be done was to get a new PD and not a library that no one used in the first place. 2. I would like to see the sewer system expanded. 3. I would like the trash pick up to continue this should not even be an opt out item.
- We are being "threatened" by the major developers, particularly REI. If this plan goes through on Dearborn Road we would have 75 new families in (an effectively) one lane road! We need to take back our town from the bullies that threaten the town with lawsuits because of a need to limit growth. 2. Our police station is inadequate! We need to focus funds and energy on providing the people that save lives and keep our community safe with a decent, safe workplace. The fire station needs updating as well.
- We are now the highest property tax in the state. Plans call to raise taxes 8.8%. I am in the process of looking at residential property outside of Pembroke. The property owners are carrying the burden while non-property owners don't support the town or its needs. I have lived all over the country and this area has the heaviest tax base. People are going to leave and new folks won't come to Pembroke. We need to develop tax revenues.
- We are voting on whether or not to increase the number of selectman to five. It is my opinion that five selectman, doing their jobs could easily replace the town administrator. This would go a long way toward balancing the budget. Also the town report should list the individual salaries for each employee not just labor grade and range. This is done in other towns (Epsom example) and gives the voters an accurate accounting. The town sidewalk goes beyond the bridge at glass St. Why is the rest not mentioned?
- We believe that the biggest issue is that Pembroke severely lacks commercial businesses, which would alleviate some of our tax burden. Sometimes change is good. Pembroke is growing so rapidly (in population) that its going to have to start thinking about how to accommodate this growth spurt. Bring in more businesses.
- We cannot have another tax increase because its getting so the elderly who have homes are compelling to sell. I got a \$10 increase in my social security.
- We can't afford any higher taxes! We need to work and budget within our means and stop overspending.
- We have lived in Pembroke some 60years.

- We have not lived here long enough to be acquainted with many subjects in this survey. We like Pembroke. We bought an existing house. We will try to answer future surveys more completely.
- We must do all we can to get business to come to Pembroke, NH a good start was water and sewer on Route 106, but we have to change zoning on Route 3, its comm. from Nashua to the North Country. xxxxx xxxxx, xx.
- We must lower property taxes. People cannot afford them already and they seem to go up every year. Industry to help offset increasing costs must be introduced to the town's master plan. Growth of housing developments must be slowed down.
- We need a traffic light on Rt 3 and Pembroke Hill Road. The school bus drivers refuse to turn on Pembroke Hill Road if there are cares on that street. Maybe school district should teach them how to drive better since we don't have a light there.
- We need more business in this community to help with the taxes if we didn't I don't know how I'll be
 able to stay in the town of Pembroke which would be a shame as my children are established in the
 schools and activities and our schools are doing a good job with our children please bring in more
 businesses
- We need natural gas. The propane monopoly is outrageous!
- We need to add Retail businesses to add to our tax base to help lower our taxes. Taxes are one of the highest in the state and the town needs to figure away to help increase our tax base with businesses!
- We need to allow commercial businesses to expand in our town. We can no longer continue to pay these high tax rates which if aren't pay effects our schools. Election is extremely important. If we don't do something ... people will be moving out of Pembroke.
- We need to control spending more. We also need a better handle on speed limits on all roads including Pembroke St. 50mph is not safe for a road posted at 35 mph!
- We need to get taxes under control. I believe the town does a good job, the school committee is out of
 control and needs fresh ideas (get rid of the bad teachers & slugs, focus on real objectives of school, ie
 learn to think and reason and not how to operate a computer or be a babysitter).
- We pay one of the highest tax rates in the state. Poor management over the years has caused an increase in taxes every year to bail out the town. How many people have to move out of town before someone says enough is enough. Another 7% this year and nothing is improved or changed. Stop trying to eliminate teachers and police. When the budget cuts come we always go after the important jobs. We could live with a few sidewalks that go unplowed and bringing our own trash to the dump. Those that want the pick up should pay for it themselves. The town has allowed a mass clear cutting of trees for lots. I'll gladly pay higher taxes to live in the remote area with out all of the houses. If we are adding all the new houses then the tax rate should go down.
- We should seek to better and more efficiently serve the existing community. Encourage human development, health promotion activities, conservation, keep small town ambiance. We should not be or look like a city. We need to take care of our people. Children, elderly, etc. We should combine resources when possible; ie. Expand high school library to include community use rather than build new one. That was a truly inappropriate move! Very wasteful!
- We would like to see restriction of A.TV. use in conservation areas the town forest. The town forest on Brickett Hill is being destroyed by these vehicles.
- We've have spent hundreds of thousands of dollars on a library. I feel will be empty most of the time.
 And now you are going to stop sports in the middle school because of lack of funds. Kids with no
 sports are likely to get in trouble and not go to the library. Something to think about. Is this part of
 the Master Plan?
- What I would like to see in Pembroke is bus service.
- When I see lights on at night in The Academy I wonder why unless there children kept after school. Do others use The Academy? If so why? Also it appears to be open weekends.

- When planning subdivisions right of way for future roads should be mandated on deadends and cul de sacs. Selectmen should seriously consider not renewing the town administrator and look for a new one. Second, for a town our size we have way too many people working in the town hall, perhaps we should be looking at restructuring the town hall, downsizing staff, and restructuring jobs.
- When town turns down a library the town should not build it. Leave dump pick up as is. Schools receive to much money and give subparr education as you can tell by my spelling I went to Pembroke school system. Fire Town Manager. P. S. When you own land and pay thousands in taxes you should be able to do what you want with your land.
- While years ago votes were taken on keeping the village school in view of expanding the Hill. I wonder if it's time to reinvest the costs of running (3) elementary schools. Hill and village duplicate services, space, books, and materials, etc. I'd like to see a study of what selling the village school property and expanding hill would cost the town.
- Why does the chief live in another town he drives a do. Vehicle and he should be available for back up and major decisions. He has wants and demands but does not live in town and pay the high taxes!
- Why was the sidewalk along church street never cleared of snow this winter? Why are cars allowed to park along Broadway and Church Street which obstruct traffic an snow removal?
- Widening of Pembroke Street or alternate routes into Concord. Building indoor swimming complex multi-use like a YMCA.
- With increases in residential growth contributing to increase tax revenue why do Pembroke taxes continue to increase?
- With the taxes we are currently paying, I would expect the above categories to all be in the fair to good category. I feel the town administrator has done a very poor job of running the town and has been short sighted with long term planning. The town requires light industrial businesses to be able to support the tax structure. I know several folks who are either are or are planning to move out of town due to the tax structure and lack of a formal long term strategy.
- Work with CNHRPC to ensure that we are doing our fair share of supplying affordable housing (I think we already are way over that level).
- Work with State to consolidate SAU's.
- Would encourage, development of (Route 3 and Route 106) think that is the best area for new business.
- Would really like to see the town's web site further developed and maintained. We really, really want
 to see the tax rate go down. We like Pembroke but have no kids and are flexible to move somewhere
 else. We have seriously considered it.
- You would like more businesses in Pembroke but you keep raising the tax rate. All your doing is scaring businesses away because of high tax rate. Think about it. You spend over \$1,000,000,000 to expand the sewer on 106 than you raise the tax rate. Now to me that don't make any sense but than whom am I just another tax payer. Maybe I should mind my own business. Thank you.
