Government Land Use Application Proposal by Beth McClure and Strong Foundations Elementary School on Tax Map 632, Lot 18-9 and 18-10, located at 715 and 717-719 Riverwood Drive in the Commercial/Light Industrial (C1) Zone and the Aquifer Conservation (AC) District. The applicant, Jeff Lewis, PE of Northpoint Engineering, LLC., on behalf of Beth McClure and Strong Foundations Elementary School, has submitted a Governmental Land Use proposal that includes: plans, specifications, explanations of the proposed changes available at time of submission, a statement of the governmental use according to RSA 674:54.I, and a proposed construction schedule. Proposed Amendment #1

To amend The Planning Board application to add the following language:

PART 5. OTHER APPLICATION REQUIREMENTS

The following items are required for a complete application. The Board will make a determination at its next regular meeting, after the project has been publicly noticed, whether the application is complete.

It is recommended applicants meet with the Town Planner prior to application submission to ensure the application contains the correct and complete information.

Unless deemed unnecessary by the Planning Department, ALL applicants shall attend a Technical Review Committee (TRC) meeting prior to being placed on the Planning Board Agenda.

Assuming that amendment # 1 is adopted by the Planning Board, and also to make various administrative and grammatical changes to the application. The full text of the proposed application changes are available for public inspection at the town offices.
