



## **PREFACE**

Tri-Town Emergency Medical Service was created in June of 2012 and began operation in January of 2013. Prior to that date the Tri-Town Volunteer Emergency Ambulance Service was a non-profit entity that once provided ambulance service to the Towns of Allenstown, Hooksett and Pembroke. The Town of Hooksett now provides ambulance services through its fire department.

Under New Hampshire RSA 53-A, the Towns of Allenstown and Pembroke entered into an intermunicipal agreement to create a public entity to provide ambulance service for both communities. A Board of Directors is the governing body for the Service in accordance with this agreement. The ambulance is housed at the Pembroke Safety Center. The Service is staffed 24 hours per day, 7 days per week at the *Paramedic* Level. The cost of the Service is partially subsidized by funding provided from each town on a percentage basis in accordance with the provisions of the agreement. The Service also bills patients through a third party billing firm making up the remainder of the revenues that pay for the cost of operations.

Tri-Town EMS utilizes Concord Hospital as its Medical Resource Hospital and provides Emergency Medical Care under the coordination and guidance of Dr. Nicolas Larochelle. As part of the Medical Resource Hospital Agreement (MRH), Tri-Town EMS receives many of the medications and supplies the Service needs from Concord Hospital.

This report was created on May 7, 2018, by the Service Director, Christopher Gamache BS, NRP. This document contains data that was obtained from the New Hampshire Department of Safety, Bureau of Emergency Medical Service patient care reporting website, <a href="www.NHTEMSIS.org/elite">www.NHTEMSIS.org/elite</a>, where all patient records for the Service are maintained. Tri-Town EMS is dispatched by Concord Fire Alarm who maintains all the times associated with the Service's EMS Incidents. Financial data has been provided by the Town of Pembroke and by ComStar Ambulance Billing.










During the month of March, I continued to consolidate our policies and creating policies that are needed. Ambulance 8 continues to have problems with the Air Conditioning System and there was a minor incident involving Ambulance 8.

The call volume for April was down compared to other months, but up when compared to other Aprils.

The Service received the sign copy of the MRH with Concord Hospital. There were some changes specific to insurance coverage to match Primex's coverage for municipalities.



Ambulance 8 went to Grappone Ford at the beginning of the month and representatives from PL Custom assist the Ford technicians in trouble shooting AC problem and leak(s). The system some repairs were made and the system was charged. A leak was found at a connection and PL Custom had the part ordered. The following week PL Custom came and replaced the part. Determined the leak was from a rolled O-ring. The ambulance was brought back to Grappone Ford to be recharged. It was too cool for them to test the system. Within a week, the crew reports the AC system is still not working. Grappone Ford is unable to take the truck back in until a month and a half.

PL Custom makes an appointment at Merrill's Radiator at 29 Pembroke Rd in Concord. The ambulance was sent there on May 10<sup>th</sup>. Merrill's finds the low pressure side has high pressure and the high pressure side has low pressure. Furthermore, the low pressure side and the high pressure side have the same pressure (equalized). They state the compressor has failed and needs to be replaced. They also state there may still be a leak in the AC system or the leak could be the compressor itself. The compressor will need to be replaced to determine if the leak was there or not.

Grappone was contacted they are currently working on ordering the part and will set a repair date when they have the part. Incidentally, the Service was made aware that Dover Fire Department, who took delivery of two (2) ambulance from PL Custom on Ford F450 Chassis had the same problem. Dover received their ambulances a week after we received ours.

The crew of ambulance 8 drove around the back of the Public Safety Center to respond to a call. The driver rubbed up against one of the bollards by the police side (exit of the sally port), damaging the rub rail on the driver's side of the ambulance. The incident was reported to the town and to Primex. The incident caused \$832.00 in damage to the ambulance. The damage was repaired by PL Custom.



- The Service is working with the Allenstown Police Department to put on a CPR course for the department. Also the Service is currently scheduled to put on a CPR course for Pace Academy in Allenstown for students and faculty. Pace Academy has 15 people they are trying to certify.
- The AEMT course continues.
- April marks the beginning of the new NCCP cycle for the Service.
- Driver Training Program (PowerPoint) was developed.
- Driver Training of new employees was conducted and continues.

- Crews were reminded to document procedures and medications.




