



### **PREFACE**

Tri-Town Emergency Medical Service was created in June of 2012 and began operation in January of 2013. Prior to that date the Tri-Town Volunteer Emergency Ambulance Service was a non-profit entity that once provided ambulance service to the Towns of Allenstown, Hooksett and Pembroke. The Town of Hooksett now provides ambulance services through its fire department.

Under New Hampshire RSA 53-A, the Towns of Allenstown and Pembroke entered into an intermunicipal agreement to create a public entity to provide ambulance service for both communities. A Board of Directors is the governing body for the Service in accordance with this agreement. The ambulance is housed at the Pembroke Safety Center. The Service is staffed 24 hours per day, 7 days per week at the *Paramedic* Level. The cost of the Service is partially subsidized by funding provided from each town on a percentage basis in accordance with the provisions of the agreement. The Service also bills patients through a third party billing firm making up the remainder of the revenues that pay for the cost of operations.

Tri-Town EMS utilizes Concord Hospital as its Medical Resource Hospital and provides Emergency Medical Care under the coordination and guidance of Dr. Robert Rix. As part of the Medical Resource Hospital Agreement (MRH), Tri-Town EMS receives many of the medications and supplies the Service needs from Concord Hospital.

This report was created on April 9, 2019, by the Service Director, Christopher Gamache BS, NRP. This document contains data that was obtained from the New Hampshire Department of Safety, Bureau of Emergency Medical Service patient care reporting website, <a href="www.NHTEMSIS.org/elite">www.NHTEMSIS.org/elite</a>, where all patient records for the Service are maintained. Tri-Town EMS is dispatched by Concord Fire Alarm who maintains all the times associated with the Service's EMS Incidents. Financial data has been provided by the Town of Pembroke and by ComStar Ambulance Billing.









- Call volume for the year remains down, however March 2019 saw the same number of runs as March 2018 with one more transport. The Service is still on a trend to exceed the total number of transports from last year.
- Ambulance 8 was sent to Above All Collision to have the damage from January repaired. The ambulance returned and the decals had an excessive amount of air bubbles in them. Waiting on hearing back from Above All Collision for a solution.
- The Zoll AEV Ventilator was placed into service on Ambulance 8. The vent was used 3 time and on all 3 cases, the paramedic placed the patient on BiPAP.
- Advertising and working applicants through the hiring process was a priority for March.



#### **AMBULANCE 8**

- Ambulance 8 was used on 71 incidents in March.
- Ambulance 8 was sent to Above All Collision in Concord in March to have minor damage repaired following an incident where the ambulance rubbed up against a building in January. The ambulance was at the shop for just over a week. Upon return back to the station, most of the graphics that was applied had a significant amount of air bubbles. Above All Collision was called and we are still waiting to hear back from them.



#### **AMBULANCE 3**

Ambulance 3 was used on 33 runs in March.



- The Service advertise for Per Diem / Part Time Positions through the New Hampshire Department of Safety Position Announcement Service. We received 12 applications as a result of this announcement.
- Conducted 6 interviews and are continuing the hiring process on 4 of those applicant. Will interview at least 3 of the remaining applicants with the goal of hiring another 2. With the expected departments coming, this will bring our roster to about 30 employees.
- Two Per Diem Employees who have worked a significant number of hours are cutting back or will not be working. One has taken a new job and the other is being deployed.
- One of our Per Diem Employees has requested to be Part Time on weekends (Sunday).

 Right now, we potentially will have Saturday (24 hours) covered with two paramedics, and Sunday will have both Paramedic and AEMT positions filled, thus fully staffing the weekends.

#### QUALITY ASSURANCE

- Follow up was required with a paramedic who undertreated a potential Sepsis patient.
- Continuation of documentation issues see with not documenting phone numbers, social security numbers, some procedures and medications. Affected employees were contacted.
- Paramedic Ryan Hornblower and Advance EMT Daniel Fitzgerald identified a patient having a STEMI (heart attack), provided appropriate treatment and notified the hospital. The patient was sent to Concord Hospital's Cardiac Catheterization Lab for treatment.
- Two (2) nitroglycerin infusions were performed in March.
- BiPAP (Zoll Ventilator) was applied three (3) times in March.




