

TOWN OF PEMBROKE TRUSTEES OF TRUST FUNDS MEETING MINUTES

December 3, 2018

Pembroke Town Hall 311 Pembroke Street

The meeting was called to order at 6:37 p.m.

The first order of business was the review of the minutes of the meeting of February 5, 2018. Trustee Eschbach made a motion to approve the minutes as written, which received a second from Trustee Crean. The vote was all in favor and the motion passed.

The motion was offered by Trustee Crean to ratify the entire list of poll votes, which received a second from Trustee Eschbach. The Chairman called the vote and it was all in favor.

Chairman Fleury then briefed the trustees on a communications from the Department of Justice regarding new submission procedures for the MS-9 and MS-10 forms. He reported that he would work with the Town Administrator to obtain a municipal administrator account for the Town and would format the Town's data for electronic transmission at the end of 2018. He then stated that the next meeting would be scheduled for a date to be determined in February of 2019. At that time, the investment policy would be brought up for annual ratification and the MS-9 and MS-10 forms would be signed as a prelude to their submission.

There being no further business to conduct, Trustee Crean offered a motion to adjourn which received a second from Trustee Eschbach. The vote was all in favor and the meeting adjourned at 6:45 PM.
